



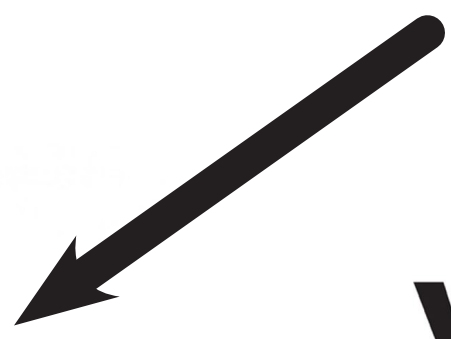

ASSOCIATION GOVERNANCE AND ORGANIZATION

REALTOR® associations on the local, state, and national level all have a part in enforcing policies and standards that protect the associations and help the organization run smoothly. As an elected leader, it's crucial that you understand the relationships between the different types of associations and the rules that govern them. While the National Association of REALTORS® sets policies and provides overall leadership, the local associations have the most direct connection with members.

LOCAL ASSOCIATION POLICIES AND STRUCTURES

To its members, the local association is the most visible and familiar component of the REALTOR® organization. It is at this level that members can actively participate on a regular basis and contribute to achieve common goals to better the industry.

BOARD OF DIRECTORS

The governing body of the NCAOR shall be a Board of Directors consisting of the elected officers, ten (10) REALTOR® members of the NCAOR, plus the immediate Past President. All directors including the elected officers have one vote. Directors shall be elected to serve for staggered three (3) year terms.

COMMITMENT OF ATTENDANCE AT MEETINGS, FUNCTIONS, ETC.

Leadership effectiveness at the Association is achieved by attendance. Attendance at monthly Board of Directors meetings is not only crucial to having adequate representation in carrying out the business of the Association, but also to provide the visual and demonstrated commitment of contributing to the success of programs, projects and events.

BOARD OF DIRECTORS COMPOSITION:

- ◆ Ten directors
- ◆ Secretary
- ◆ Treasurer
- ◆ President-Elect (automatically progresses to the position of President)
- ◆ President (previously elected)
- ◆ Immediate Past President

QUALIFICATION REQUIREMENTS FOR DIRECTOR SEATS:

- ◆ Member in good standing
- ◆ A minimum of two years membership at the local association.
- ◆ Served a minimum of two years on a local NCAOR Committee
- ◆ Must be actively engaged in the Real Estate Business
