



# Honorary Member-for-Life Application

## CALIFORNIA ASSOCIATION OF REALTORS®

### **Requirements for Qualification**

REALTOR® Members of the State Association must meet the following two criteria to qualify for C.A.R. Honorary Member-for-Life status:

1. must have been a C.A.R. member for a minimum of twenty-five (25) years, and;
2. must be 75 years of age or older

### **Privileges**

Upon approval, State Association dues shall be deemed paid-in-full for life (commencing the year following approval) and the Honorary Member-for-Life shall be entitled to all rights and privileges of State Association membership accorded to all members; however, in order to retain REALTOR® status, Honorary Members-for-Life must maintain their local and National Association memberships.

### **Application Submission**

C.A.R. will only accept completed applications for Honorary Member-for-Life from the member's local association and will not be processed without the signature of the Association Executive.

The C.A.R. Board of Directors must approve all Honorary Member-for-Life applicants. Applications must be received no later than 15 days prior to a regularly scheduled Board of Director's Meeting in order to be considered for approval. **IMPORTANT:** In order for state dues to be waived next year, applications must be submitted prior to the Fall C.A.R. Business Meetings.

**Please include proof of age with the application.** Acceptable forms of identification should include the member's name and birth date (i.e. copy of driver's license, passport, photo ID, etc.).

### **Procedure**

Names of qualified applicants will be placed on the Consent Agenda for approval by the C.A.R. Board of Directors. Those approved for Honorary Member-for-Life status will receive a congratulatory letter from the C.A.R. President and CEO, and certificates will be mailed to the local Association for presentation to their Honorary Member-for-Life designees.
